- ◇ Dues and or initiation payments may be made by **cash, debit, money order or cashier's check.**
- ◇ Your Union dues are **\$40.00 dollars per month** and they are due on the first day of each month. We do not send reminders (monthly dues are not deducted out of your pay check). **You can make a payment online by login to members.local89.org - add your Social Security number and your password is the last 4 of your SS#.**
- ◇ **If you are two months behind on paying your dues, you will be suspended on the first day of the third month.** If you become suspended, you will need to pay your back dues plus a penalty in order to reinstate your membership.
- ◇ If you are suspended you will receive a 10 day suspension letter, followed by a 48 hour suspension letter, then an immediate removal from your job.
- ◇ You will receive a **Membership Card** in the mail once you paid the full initiation and it is processed by the International Union, approximately **8 to 12 weeks after joining, except PSA Core Employee or Non Members.**
- ◇ **You must be a member for 6 months before you may transfer to a different Local Union.** You have 30 days in which to deposit your transfer with another Local Union or to return it to this office. In order to receive a transfer your dues must be paid through the current month approved by the Business Manager/Secretary-Treasurer. Transfers for Apprentices must be approved by the Executive Board Meeting.
- ◇ If your name is on the Out-Of-Work list, **dispatch hours are from 7:00 a.m. to 9:00 a.m. Monday through Friday.** If you are unavailable during the posted dispatch hours, you will be dropped from the Out-Of-Work list.
- ◇ Please be advised that you will be removed from the Out-of-Work list if you **work a total of 40 hours, 5 days, or if you complete 2 dispatches.** It is your responsibility to re-register back on the Out-of-Work list after you are laid off, we will call the Contractor and verify actual hours worked.
- ◇ **Roll Call is on the 1st Friday of each month beginning at 7:00 a.m. and ending at 11:00 a.m., you must show a picture I.D. and sign in.** If the 1st Friday is a Holiday, Roll Call will be done the following Friday. **If you do not show up for Roll Call your name will be taken off the list and will not be put back until you call the Union.**
- ◇ **The Unions' General Membership Meetings are held at 4161 Home Avenue, San Diego, CA 92105 on the third Tuesday, at 6:30 p.m. for the months of January, February, April, May, July, August, October and November. The Quarterly meeting will be held every third Saturday at 10:00 a.m. for the Months of March, June, September and December.**
